# Capture and Types of Information Collected Data Collected

Data which may be made available or gathered via your use of the Site may be ("Non-personal Information"). With this data, we are not aware of the identity of a User from which the Non-personal Information was collected. Non-personal Information which is being collected may include your aggregated usage information and technical information transmitted by your device, including certain software and hardware information (e.g. the type of browser and operating system your device uses, language preference, access time, etc.) in order to enhance the functionality of our Site. We may also collect information on your activity on the Site (e.g. pages viewed, online browsing, clicks, actions, etc.).

Additional Data which may be made available or gathered via your use of the Site may be ("**Personal Information**") which is individually identifiable information, namely information that identifies an individual or may with reasonable effort identify an individual. Such information includes:

 Device Information: We collect Personal Information from your device. Such information includes geolocation data, IP address, unique identifiers (e.g. MAC address and UUID) and other information which relates to your activity through the Site.

We never sell, rent or share Personal Information and/or Contact Information with third parties except as described in this Privacy Policy.

#### Registration:

If you participate in interactive activities (event and program registration, membership programs, information requests) on the Site, you may be asked to register for a login and password and/or to provide information on registration forms. Unique identifiers, such as logins and passwords, are collected to verify your identity and for use as account numbers in our records system. Your contact information may be used to contact you when necessary for customer



service reasons. Financial information collected is used exclusively to bill you for the service or product that you specifically requested.

#### Cookies:

"Cookies" are small pieces of information that are stored by your browser on your computer's hard drive. Generally, cookies work by assigning to your computer a unique number that has no meaning outside of our Site. Our cookies do not contain any personally identifying information. We may also use cookies to assist us in delivering content specific to your interests. Most Web browsers automatically accept cookies, but you can usually change your browser to prevent that. #### Uses of Information Collected

We use Contact Data to send you information about our products or services or to contact you when necessary. #### Retention
